### **6-2-7: LICENSES AND PERMITS REQUIRED:**

**Annual License: Any person who shall keep or harbor any dog on his premises shall pay a city license fee per annum for each spayed or neutered dog, and a different fee per**

**annum for each intact dog so kept or harbored on such premises. Licenses are available throughout the year but must be renewed on or before January 1 annually.**

6-2-11: OWNER RESPONSIBILITY:

**E. Off Premises: When off the premises, dogs must be restrained by a leash not exceeding six feet (6') in length. An exception is when the owner or keeper physically carries or holds said animal in his hands. Nothing in this section shall be construed as allowing any animal under physical restraint to commit any act defined as unlawful in this chapter.**
